 - An interest in hearing more about third party temporary agencies was presented

• Testimony by Cope Family

- Mrs. Cope: main goal safety procedures, specific protocols, for these buildings, emergency would look like, that would be family's goal, for them to take responsibility
- Mr. Cope: would like to see emergency response plain, have a focal point, monitor when there is extreme weather, someone there, in case a situation, plan ahead, and get them into a safe and designated place. Have a plan and to get those people into that place in timely.

• Board Discussion and Input

- Sen. Ventura: themes for task force, Director discussed three focus areas. Next meeting would be on structural safety. Sen. Ventura would like to see building codes and building standards.
- Marcos Ceniceros: we see a lot of pollution around the warehouse parks. Assess land and surrounding areas.

- Discussion included would like to look at issues of state jurisdiction. Wants to keep task force focused on what we can manage and legislate, and structural safety or warehouses. Structural discussion could be had at the next meeting.
- Next meeting to focus on next structural safety and physical warehouse structures. Masonry industry was discussed as possible presenter at next meeting.
- o Code enforcement was raised as possible area of exploration by the task force
